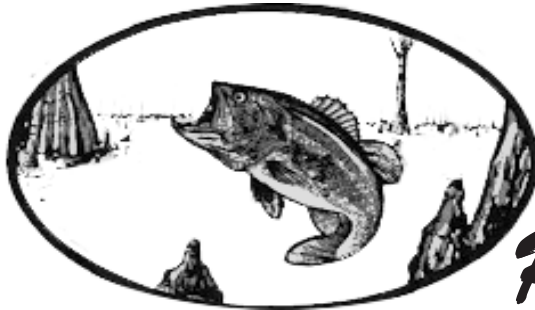

Official Tournament Rules

1. **Life Jackets** - Must be worn when main engine is running.
2. **Live Wells** - Must be of adequate size and provide aeration.
3. **Size and Possession Limits** - 13" minimum length; 5 fish per team. Fish will be measured on a Wil-E-Go belly board. Fish are to be culled as necessary so as not to exceed the possession limit.
4. **Penalties** - Dead fish weight will be allowed, less a 2 ounce deduction per dead fish. Anyone weighing in a fish smaller than the 13" minimum will have one pound deducted from the total weight for each fish. Any fish that appears to have been altered or mutilated, in the tournament director's judgement, will be deemed illegal, and one pound will be subtracted from the total weight for each such fish.
5. **Fishing Methods** - Only artificial lures may be used and all fishing is to be done from a boat.
6. **Speed Restricted Areas** - All 5 mph zones are to be observed.
7. **Infringement** - No contestant may move within 25 yards of another contestant's boat for the purpose of fishing.
8. **Sportsmanship** - Any contestant who displays poor sportsmanship will be disqualified.
9. **Beverages** - No alcoholic beverages are allowed in the boats or to be consumed during the official tournament hours prior to weighing in.
10. **Boat Inspection** - All boats will be subjected to a livewell inspection prior to blast-off and will be issued an inspection card. Any boat not inspected will be disqualified.
11. **Weigh-In** - Contestants who have not checked in at the official check point on time will be disqualified.
12. **All State of California Fish and Game rules apply.**
13. **All Ruth Lake Water District rules apply.**
14. **Pre-Fish** - Lake will be off limits to ALL fishing by competitors (including youth anglers) on the Saturday prior to the day of the tournament.
